6. Transformer Details: It is mandatory to provide Details of Transformer, History Sheet and Customer Details as indicated in data sheet enclosed herewith along with samples. Copy of previous results pertaining to Dissolved Gas Analysis Test, available if any, may please be provided along with the sample.

7. Sampling: Sampling of the oil should be done as per IS: 6855-2003. Samples are to be deposited to this Laboratory in Steel Container / Plastic Can / Glass Bottle (amber colour). The container should be tagged with proper identification mark including name & address of the sender. Container should be filled completely and there should not be any air ingress in the sample container.

It will be Customer's responsibility to arrange for submitting the sample to be tested to this laboratory and also to collect back empty sample bottles from this laboratory.

8. Test Report: The test report will be handed over after receipt of payment within **seven working days** to your authorized representative or will be dispatch by Post / Courier / by email on request against the samples received to this laboratory.

9. Responsibility: This laboratory will not be responsible for any of the observations & recommendations made in the Test Report. The specific comments under observations / recommendations on the Test Report are purely based on sample received & results obtained. You may take opinion from expert in the field, for further action at your end.
