- 1] The advertisement shall be printed in English , Marathi & Hindi language only.
- 2] The size of the MSPGCL's (MAHAGENCO) emblem should be only 2.5 cm in which for both single column and for more column
- 3] For single column the company's emblem should be invariably printed at the top in the centre of the advertisement and for double or more column it should be invariably printed at the left hand corner at the top of the advertisement.
- 4] In case of single column advertisement the Heading such as "Advestiment" should be displayed invariably below the emblem.
- 5] In case of double or more column advertisement, the heading such as "Advestiment" should be displayed invariably at the right side of the emblem.
