4. Minimum Qualifying Requirements for the Bidders:

The Bidder should meet the following requirements:

4.1. Qualifying requirements:

4.1.1. Technical Criteria:

- 4.1.1.1. The Bidder, based in India, should have supplied Coal Flow Management System (Air Blaster / Canon system) in a pulverized Coal fired Power Plant of capacity not less than 200MW to MSPGCL / NTPC /SEB's/ Public Sector undertaking/ Central Power generation company/(Approved sub vendor of EPC/ Turnkey/BoT contractor of Mahagenco).

4.1.2 Financial Criteria:

- 4.1.2.1 The bidder should have annual average turnover for any three years in last five (5) years equal to estimated cost of the tender items.
- 4.1.2.2 The bidder should produce the copies of statement of Annual Accounts for previous three / five years duly certified by a Chartered Accountant or produce a certificate of annual turnover during previous three / five years duly certified by a Chartered Accountant.

4.1.2.3 Net worth

a. The net worth of the tenderer / bidder as on 31st March of previous financial year shall not be less than 25% of its paid up share capital. miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus. Other income shall not be considered for arriving at annual turnover.

b. The Bidder should submit the documentary evidence in respect of above. In case audited results for the last preceding financial year are not available, certification of financial statement from practicing Chartered Accountant shall be acceptable.

4.1.3 Terms & Conditions of the Tender

- i) If the manufacturer does not furnish the Performance Bank Guarantee, then the Authorized Dealer / Channel Partner will have to submit the Performance BG equal to 10% value of order.
