Inviting "Expression of Interest" for sale of fly ash "Free of Cost" from interested agencies having experience in transportation of fly ash by Railway wagons from Khaperkheda TPS.

Khaperkheda TPS Mahagenco has 5 no. running units with generation capacity of 1340 MW. Ash Silos are available in units 3,4 & 5. Daily total dry fly ash available at unit 3,4 & 5 is about 3500 MT. There are 3 remote silos for 210 MW combined having capacity of 300 MT, 300 MT and 120 MT each. There are 2 remote Silo's for 500 MW units having capacity of 1125 MT each direct filling facility is only available at unit no. 5 i.e. 500 MW. Mahagenco is planning to transport dry fly ash generated at Khaperkheda TPS b railway wagon to the genuine bulk ash users like Cement industries and RMC plant. In view of the above Khaperkheda TPS of Mahagenco is publishing E.O.I. to invite interested agencies having experience in transportation of fly ash by Railway wagons in Jumbo Bags from Khaperkheda TPS of Mahagenco.

Preamble:

MAHAGENCO is a Maharashtra State Government Undertaking Company. MAHAGENCO has its registered office at Prakashgad, Bandra, Mumbai.

In line with the directives from MoEF & CC, to increase the fly ash utilization at MAHAGENCO's various thermal power stations, MAHAGENCO is exploring various innovative ways. As a part of this, MAHAGENCO is planning to transport Dry Fly Ash generated at Khaperkheda TPS by Railway Wagons in Jumbo Bags to Mumbai, Pune etc. to the genuine bulk fly ash users like Cement industry or RMC Plants.

MAHAGENCO invites Expression of Interest from the interested agencies having experience in transportation of fly ash by Railway wagons in Jumbo bags from Khaperkheda TPS of MAHAGENCO Dist: Nagpur (M.S.).

Qualification Criteria: The interested agencies should fulfill the following criteria:

- 1. The agency/organization should have an Income Tax Permanent Account Number (PAN) and valid GST Registration.
- 2. The agency/organization should have a valid certificate of incorporation as proprietary firm/partnership/company under partnership act/company act from appropriate authorities.
- 3. The agency/organizations should have experience of transportation fly ash/coal/any other commodity by Railway wagons in Jumbo bags/open wagons/ BATP wagons from any Government or Private Thermal Power Station during last 05 (Five) years for own or for any other genuine end users.

Present Scenario of Fly Ash Loading at Khaperkheda TPS:

- i) Ash silos are available at U-3, 4 &5. Daily total dry fly ash available at U-3, 4, 5 is @ 3500 MT.
- ii) There are three remote silos for 210 MW combined having capacity of 300MT, 300MT and 120 MT each.
- iii) There are two remote silos for 500MW units having capacity of 1125 MT each, which requires 28 hrs. to empty.
- iv) Direct wagon filling facility is available only at Unit no. 5 i.e.500MW.

Modalities & Assistance by MAHAGENCO to the prospective bidder:

- 1. Mahagenco will permit the bidder/organization to load fly ash from Khaperkheda Thermal Power Plant siding inside plant area. MSPGCL has no claims regarding the quality of dry Fly ash & ash will be made available on as is basis.
- 2. MAHAGENCO will provide the required loading points near the railway track.
- 3. Mahagenco will provide Locomotive for shunting of Rake/ Wagon on Free of Cost basis for handling of Fly Ash load inside its premises.
- 4. Mahagenco will provide suitable land and water arrangements for installation of plant and for stacking & packing of jumbo bags, within the Plant premises. A rent of Rs.1/- per Sq.Ft. per month would be charged for the entire area allotted to the agency, which will have to be deposited by them monthly in advance on or before the 10th day of every month.
- 5. Mahagenco will give Co-user permission to the agency/organization only for transportation of fly ash by rail from thermal power plants so as that it will be convenient to the agency/organization to make indent for rakes and pay the freight & other statutory charges to Railways directly.
- 6. In case of non-availability of fly ash due to reason beyond control of Mahagenco/forced outages of Power Plant etc. the same shall be communicated to the Agency and further restart schedule of Ash loading/transportation shall be jointly worked out between Power Station & the Agency.

Scope of the bidder/organization:

- 1. Fly ash will be loaded from thermal power plant in all modes of Rail transport like Jumbo bag through BCN and BOX N Rake, for bulk Transportation BCFC, BTAP, BCCW Wagons or any other suitable wagons will be used by the bidder/organization.
- 2. The bidder/organization will arrange the wagons/rakes etc. for transportation of fly ash.

- 3. The bidder/organization will arrange all loading equipment like hydra or any other arrangements for loading fly ash into wagons at loading point as well as arrange Truck/tractor trolley for internal transportation of jumbo bags.
- 4. The bidder/organization will arrange all unloading equipment's/ arrangements for unloading of fly ash at unloading point.
- 5. The bidder /organization will provide all the loading/packing material i.e. Jumbo Bags etc. for filling/storing of Ash at loading point at the Power Station.
- 6. The bidder/organization will operate and maintain the bagging/packing plant at source and will arrange all the manpower required for loading and unloading of the fly ash.
- 7. The bidder /organization will create the storage facility at the unloading point with consent from KPKD Power Station.
- 8. The bidder/organization will have entire responsibility for marketing and disposal of the transported fly ash to the End users, by observing all MPCB norms.
- 9. The bidder /organization will bear all the payments related to Rakes including Railway Freight, Demurrage (not withstanding Forced outages of the MSPGCL Power Plant Units), Siding charges/siding development charges as per Railways, PSU terms & conditions. Mahagenco will not be responsible for such payments. The Agency/organization shall stack the ash filled jumbo bags in sufficient quantity prior to arrival of rakes to avoid demurrages.
- 10. The bidder /organization will abide and solely responsible for all the rules and regulations for labor and wages, safety, RTO/MPCB norms & statutory requirements.
- 11. The bidder /organization will lift fly ash on continuous 24hrs x7 days a week basis subject to availability of fly ash in the silos.
- 12. The agency /organization will inform Mahagenco one day in advance before placement of rake for loading of rake.
- 13. The agency/organization will have to pay electricity charges as per tariff of MSEDCL commercial rates which will have to be deposited by them monthly. Supply arrangements like HT/LT cable trays, meters will be bourn from the bidder, necessary supply feeder will be provided by MSPGCL.

- 14. Only outlet pipe, loco for wagon movement and electrical supply connection will be provided by Khaperkheda TPS. Rest all, the inlet valves, rotary feeder, and all other downlines valves, air with air compressor, lighting arrangement, etc to be carried out by the agency.
- 15. Housekeeping, lifting, loading transportation of leak ash to be handled by agency.

Time Period:

The contract period for this work will be 3 (Three) years. However, at the end of the year the performance will be reviewed and based on Performance, Mahagenco may continue the contract for another year.

Taxes and Duties:

The bidder/organization shall be liable and responsible for payment towards any taxes, duties, levies, GST etc. Applicable/ enforced (By State/Central Government) from time to time during the tenure of the contract. Such liabilities, if any, shall be paid by the agency extra at actual without having any financial implications to MAHAGENCO.

Security Deposit:

The selected bidder/organization have to deposit a sum of Rs.20,00,000.00 (Rs. Twenty lakhs only) as a security deposit in the form of Bank Guarantee from a Nationalized Bank. Pro-forma for same will be provided by MAHAGENCO.

Penalty:

In the event if the agency fails to meet the 80% of assured annual target utilization levels, Mahagenco will have the right to levy a penalty of 20% amount of the total Bank Guarantee which shall be paid by the agency on a yearly basis. It will be recoverable from Performance Bank Guarantee, if not paid within a period of one month.

Pollution Control and Transportation of Fly Ash:

All possible measures would be taken by the bidder/organization to avoid pollution to the satisfaction of the plant officials. Similarly, while transporting, no spillage of

fly ash would be permitted to avoid air pollution. If the process adopted by the agency is found to be deficient, MAHAGENCO retains the right to supply forthwith.

Safety:

The bidder/organization would be responsible for the safety of its people for which the agency should provide necessary safety gear to its workers. The agency shall be fully responsible for maintaining all the insurance covers as per law of land at its own cost.

Working Hours:

Delivery of Fly Ash is intended to be round clock on all days including Sundays and Holiday or as per the instructions of Engineer-in- charge.

Authorized Person:

A proper authorization letter must be presented to MAHAGENCO if the bidder wants to depute any agent/transporter on its behalf.

Other Important Conditions:

- i) The bidder and its transporter would be entirely responsible towards RTO/Railways for overloading of fly ash, MAHAGENCO in any case will not be held responsible for the same.
- ii) The loading completion time of filling ash into wagons varies depending upon the availability of ash in silos, system readiness etc. Hence, MAHAGENCO is not responsible for any demurrage for the railway rake deployed.
- iii) MAHAGENCO reserves the right to supply the quantity not lifted by the agency to any other party at the sole discretion of MAHAGENCO.
- iv) The bidder should depute his authorized representative at the power station for co-ordination and taking delivery of fly ash.
- v) The bidder will be responsible for any kind of injuries or accidents caused to its employees, laborers, any other person or object and MAHAGENCO will not be held responsible in the matter. The agency shall indemnify MAHAGENCO if any such incident occurs.
- vi) The bidder and his transporter (s) shall have valid license, permissions etc. Of statutory, state /central govt. Authority for transportation of fly ash/coal/any other commodity for both road/ rails as applicable.
