Invites Expression of Interest (EOI)

For Lifting and transportation of fly ash by rail / road mode from Koradi TPS.

Preamble:

Maharashtra State Power Generation Company Limited herein referred to as Mahagenco has the highest overall power generation capacity and the highest thermal installed capacity amongst all the state power-generating utilities of India.

In line with the directives from MoEF & CC, to increase the fly ash utilisation at Mahagenco's various thermal power stations, Mahagenco is exploring various innovative ways. As a part of this, Mahagenco is exploring the possibility wherein genuine bulk fly ash users shall lift and transport dry fly ash generated at Koradi TPS by rail/road mode.

Mahagenco invites Expression of Interest from the interested agencies for lifting and transportation of fly ash by rail/road mode from Koradi TPS (3x660MW) of Mahagenco with financial assistance.

Qualifying Requirement:

The bidder should satisfy all the below mentioned criteria;

- 1. Average annual financial turnover during the last 3 years, ending 31st March of the previous financial year should be Rs.50 Cr.
- 2. The bidder should have minimum 5 years of experience of fly ash utilization in cement production at own facility
- 3. The bidder should have experience of transportation of 5 lakh MT of ash by rail / road mode during last 3 years.
- 4. The bidder should have system for transportation of fly ash through rail /road mode via railway wagons, bulkers, closed body vehicles etc.
- 5. The bidder who is in litigation with Mahagenco or its subsidiaries will not be eligible to participate in this EOI.

General terms and conditions

- 1. The bidder should have Income Tax Permanent Account Number (PAN) and valid GST Registration.
- 2. The bidder should have valid certificate of incorporation as proprietary firm / partnership / company / JV firm under Partnership Act / Company Act from appropriate authorities.
- 3. Consortium is not allowed.
- 4. Any Government or any other organization should not have blacklisted bidder / agency. Authorized Signatory (s) of the firm to submit an undertaking to this effect.

- 5. Submit relevant documents duly attested by the authorized signatory in support of the eligibility criteria.
- 6. An undertaking to the effect that no person of the firm /partner is related to any employee of Mahagenco nor have any interest in their activities.
- 7. The applicant is required to submit documentary evidence in support of qualifying criteria. The applicants meeting the above criteria shall only be considered for evaluation.

Scope of Mahagenco:

- 1. Mahagenco will permit the agency for loading of fly ash from Koradi Thermal Power Plant inside plant area. Mahagenco has no claims in regards to the quality of dry fly ash & ash will be made available on as is where is basis.
- 2. Mahagenco will give Co-user permission to the agency only for transportation of fly ash by rail from thermal power plants so that it will be convenient for the agency to make indent for rakes and pay the freight & other statutory charges to Railways directly.
- 3. In case of non-availability of fly ash due to reason beyond control of Mahagenco or forced / planned outages of Power Plant etc, same shall be communicated to the agency. Further restart schedule of ash loading / transportation shall jointly be worked out between Power Station & the agency.
- 4. Mahagenco shall provide suitable loading point near silo for filling of ash in bulkers / closed body vehicles etc. for road mode transportation.
- 5. Mahagenco cooperation is subject to existing infrastructure & facilities as on date. Further improvement in near future shall be informed to the agency.

Scope of the agency:

• Rail Mode:

- 1. The agency shall arrange required number of rakes on dedicated basis owned or leased.
- 2. The agency shall deploy manpower at respective Railway Division Office, loading & unloading stations for smooth movement of rakes, coordination with railways for its entire movement for faster turnaround of rakes.
- 3. The agency shall pay all maintenance costs of the rakes engaged.
- 4. Payment of Railway freight and other charges as applicable and shall be in the scope of the agency.

- 5. Co-ordination with Railways for periodic maintenance and bear all the to and fro costs including other charges, as applicable.
- 6. Insurance of rake/rakes deployed.
- 7. Wagon should have covering arrangement or of closed type.
- 8. The agency will make all the arrangements for ash loading and internal transport from silo to the wagon loading point.
- 9. The agency will make all the arrangements at ash unloading point.
- 10. Arrangement of jumbo bags shall be done by the agency.
- 11. All Statutory approvals and compliance required for the rake movement.
- 12. The agency must provide end-use utilization certificate.
- 13. The agency will inform Mahagenco in advance before placement of rake for loading.

Road Mode

- 1. The agency shall arrange required number of bulkers, closed body type vehicle etc. on its own for road mode transportation for fly ash and pond ash.
- 2. The agency shall deploy manpower at respective TPS for loading of ash in the bulkers, closed body type vehicle etc. on its own.
- 3. All Statutory approvals and compliance required for bulkers or closed body type vehicles etc. road movement.
- 4. The agency shall ensure ash loading in bulkers or closed body type vehicles etc. shall be done within RTO permissible capacity limit.
- 5. The agency shall lift pond ash from the area assigned by Engineer in charge.
- 6. The agency shall arrange the vehicles such as excavator, hydra, dozer, etc. required for filling of pond ash into vehicles on its own.

General Scope of Agency

- 1. The Agencies may visit the site for having complete idea of existing infrastructure and available facilities for loading of fly ash in Rail wagons.
- 2. The agency will abide and solely responsible for all the rules and regulations for labour and wages, safety as per statutory requirement.
- 3. The agency will lift fly ash on regular 24 hrs basis subject to availability of fly ash in the silos.
- 4. The agency shall be responsible for any situation arising due to spillage of fly ash during transportation.

Financial Assistance

- Financial assistance towards lifting and transport of ash by rail / road mode for Koradi TPS is Rs 100/MT including all taxes and duties as applicable.
- Payment of financial assistance shall be made annually after assessing exact quantity of ash lifted during the assessment year.

Quantity available for transportation of ash by rail / road:

- The approximate quantity of fly ash available for transportation by rail /road is 10 Lakh MT/ year
- The agency has to quote the yearly dry fly ash to be lifted and transported by rail / road for both Koradi TPS while submitting the EOI.

Additional_lifting of pond ash

- Agency has to lift and transport pond ash of quantity equal to 10% of committed annual dry fly ash quantity compulsorily other than committed dry fly ash quantity without financial assistance.
- No financial assistance for dry fly ash shall be provided in a year if the agency fails to lift the stipulated quantity of pond ash.

Time Period:

Time period of contract should be 10 years, subject to review on annual basis.

Selection Criteria:

- 1. The quantity to be quoted by the bidder should be 10 Lakh MT/year.
- 2. In case of more than one bidders quoting 10 Lakh MT/year, distances from TPS to the end-use plants shall be considered. Lowest distance shall be considered for priority quantity allocation.

Security Deposit (Performance Bank Guarantee):

The selected agency have to deposit a sum of Rs.5,00,00,000/- (Rs. Five Crore only) as a security deposit in the form of Bank Guarantee towards performance in two BG's of Rs. 2,50,00,000/- each from a Nationalized /Scheduled Bank. Pro-forma for same will be provided by Mahagenco.

Penalty:

 Performance will be evaluated on yearly basis and action as per below table shall be initiated.

- In case TPS fails to offer 80 % of yearly quantity committed by the agency due to any reason, modalities for BG encashment will not apply provided that documentary communication and evidence is attached.
- No financial assistance for fly ash shall be provided in a year if the agency fails to lift the stipulated quantity of pond ash.

Taxes and Duties:

The agency shall be liable and responsible for payment towards any taxes, duties, levies, GST etc. as applicable /enforced (By State/ Central Government) from time to time during the tenure of the contract. Such liabilities if any shall be paid by the agency extra at actual without having any financial implications to Mahagenco.

Pollution Control and Transportation of Fly Ash:

- All possible measures shall be taken by the agency to avoid pollution to the satisfaction of the plant officials. Similarly, while transporting, no spillage of fly ash would be permitted to avoid air pollution. If the process adopted by the agency is found deficient, Mahagenco holds the right to stop the supply of ash.
- Mahagenco is to be indemnified from any issue arising due to pollution caused during and after lifting & transportation of ash. Penalty due to pollution if any shall be paid to the concerned Authorities by the agency.

Safety:

The agency would be responsible for the safety of its people for which the agency should provide necessary safety equipment to its workers. The agency shall be fully responsible for maintaining all the insurance covers as per law of land at its own cost.

Working Hours:

Delivery of fly ash is intended to be round clock on all days including Sundays and Holiday or as per the instructions of Engineer-in- charge.

Other Important Conditions:

- 1. Lifting of fly ash may be done through rail mode subject to existing infrastructure.
- 2. The agency can develop rail loading infrastructure if required
- 3. The agency would be entirely responsible towards RTO/Railways for overloading of fly ash, Mahagenco in any case will not be held responsible for the same.
- 4. Loading completion time of filling ash into wagons varies depending upon the availability of ash in silos, system readiness etc. Hence, Mahagenco is not responsible for any demurrage for the railway rake deployed.
- 5. Mahagenco reserves the rights to supply the quantity not lifted by the agency to any other party at the sole discretion of Mahagenco.
- 6. The agency should depute its authorized representative at the respective TPS for co-ordination and taking delivery of fly ash.
- 7. The agency will be responsible for any kind of injuries or accidents caused to its employees, labors, any other person or object and Mahagenco will not be held responsible in the matter. The agency shall indemnify Mahagenco if any such incident occurs.
- 8. The agency shall have valid license, permissions etc. of Statutory, State / Central Govt. Authority for transportation of fly ash for both rail/road mode as applicable.
- 9. The interested agencies are requested to visit the site before submitting the EOI. If the representatives of the agency want to visit the site, they have to give prior intimation to this office on the mail id provided or on the mobile number of the contact person mentioned herein so as to arrange the security passes and local site visit.

The agency/organisations fulfilling the qualifying requirements shall submit the EOI on or before 28.03.2024, 15.00 Hrs.

- The Expression of Interest received from the interested agencies will be scrutinized in line with the qualifying requirements and shall be submitted for the approval of Competent Authority.
- The interested agency shall furnish the necessary documents (Original/Attested copies of documents attached with the application) in support for fulfilment of the qualifying criteria and other requirements, if asked for verification during scrutiny and/or even after completion of the process.
- The interested agency shall furnish work completion certificates from the concerned department in support of fulfilment of the qualifying criteria. The authority not below the rank of Executive Engineer or equivalent of the concerned Department shall issue the work completion certificate.
- The interested agency should attach attested copies of valid certificate of incorporation as proprietary firm / partnership / company / JV firm under Partnership Act / Company Act from appropriate Authority.
- The interested agency shall be short-listed based on their experience and credential submitted by them in line with Qualifying Requirements.
- EOI documents will neither be issued manually nor be sent by post or courier. Blank EOI documents can be viewed and downloaded free of cost by intending firms online on website https://www.mahagenco.in.
- Mahagenco may modify /amend the EOI conditions, extend the due date of submission, change the selection process, reject any or all application without assigning any reasons thereof.

All the interested agencies shall specifically note that the Mahagenco may demand to see the originals of the above stated certificates for verification and if the interested agencies does not produce the original certificates within 7 days of receipt of such demand, their application is liable to be rejected as non-responsive.
- 3. If it is established at any later date that the any agency has furnished false information / documents, the agency shall become liable for action, which may include, termination of contract, valid legal action and black listing.
- 4. Mahagenco reserves the full rights to reject any or all EOI offer without assigning any reason whatsoever.

• Other general conditions for selection:

- i. Mahagenco shall scrutinize the documents submitted by the agencies based on the qualification criteria specified in EoI.
- ii. The agency shall be short-listed based on their experience and credential submitted by them in line with Qualifying Requirements.
- iii. Canvassing in any form is strictly prohibited and any agency found to have resorted to canvassing shall be liable to have his application rejected summarily.
- iv. In the event of the application submitted by a partnership firm, an authorized partner must sign it or in the event of absence of any partner, it must be signed by a person holding a power of attorney authorizing him to do so, such power of attorney should be produced along with the application.
- v. Mahagenco reserves all the rights to reject any or all the application received, without assigning any reason thereof, whatsoever it may be.
- vi. The courts of Nagpur shall have exclusive jurisdiction in all the matter arising under and on account of this expression of interest.
- vii. At any time, prior to the last date of submission, Mahagenco may for any reason; whatsoever modify the EoI documents by amendment, which will be binding on all the agencies. Such amendment will be posted on Mahagenco website for all prospective agencies.
- viii. Mahagenco may at its discretion, extend the date for submission of application, if necessary.
- ix. Applications which do not fulfill any of the above conditions or incomplete are liable for rejection.
- x. Submission of an application by an agency implies that they have read all the above instructions and conditions of EoI and has made themselves aware of the terms and conditions for selection.
