4.0 QUALIFYING REQUIREMENTS OF THE BIDDER:

The bidder should meet below mentioned Qualifying Requirements in addition to the other conditions stipulated under Instructions to Bidders:

- 4.1** The bidder should have successfully completed the works of stage inspection, final inspection, quality assurance and surveillance of the Main Plant & associated auxiliaries and Balance of Plant equipment & associated auxiliaries (either for separate plants or for same plant) for at least 1 No. of coal based Thermal Power Generating Unit of minimum 250 MW capacity during a period of past Seven years. In this regard, the bidder should submit a copy of the end user's certificate for the satisfactory third party inspection services rendered by him along with supporting documents proving desired experience as mentioned above.
- 4.2** The bidder should provide satisfactory evidence about his organization to provide the Third Party Inspection Services for the Main Plant equipment and Balance of Plant equipment by detailing the setup of the inspection staff available along with their qualification & experience. Following minimum experienced staff should be available with the bidder for inspection purpose under the scope of work :
- i) Mechanical Engineers – 5 Nos.
 - ii) Electrical Engineers – 3 Nos.
 - iii) Instrumentation Engineer – 2 Nos.
- All the above engineers should have at least 5 years of experience as per the scope of this bid specification.
- 4.3** Average Annual Turnover of the bidder should be Rs. 90 Lacs or more during the last 3 years, ending on last day. The Bidder shall submit a copy of audited annual accounts statements with UDIN number as a documentary evidence of the same. In case, audited results for the last preceding financial year are not available, certification of financial statement from practicing Chartered Accountant shall be acceptable.
- 4.4** The bidder should have positive net worth as on the last day of preceding financial year. The bidder shall submit a copy of audited annual accounts statements with UDIN number as a documentary evidence of the same.
