QR and TERMS & CONDITIONS of EOI

A. Qualifying Requirement.

1. **Nature of Business:** Bidder should be ash product manufacturer (i.e. manufacturer of bricks, sheets, blocks, tiles, construction products, wall panels, cement sheets etc.) with SSI/DIC certificate.
2. Bidder should produce relevant license for their business (i.e consent to operate) from Pollution Control Board of respective area.
3. Bidder should produce documentary evidence regarding yearly Consumption capacity of 20% of declared quantity.
4. Bidders manufacturing unit should be located within **300 KM** radius of Bhusawal TPS.
5. **Following documents will be considered for making the bidders eligible EOI.**
 - i Valid consent to operate from MPCB.
 - ii Certificate from District Industries Centre regarding Manufacturing of fly ash or clay ash bricks, block and tiles.
 - iii Undertaking regarding purpose of use of fly ash.
 - iv Monthly GSTR-3B with ARN E-mail showing Monthly sales figure and GST paid thereon.
 - v Monthly or quarterly GSTR-1 or GSTR-4 whichever is applicable showing sales effected with the unit and GST liability thereon.
 - vi Copies of six monthly and annual Manufacturing Account, Profit and Loss account, Balance Sheet and Yield statement of the unit duly certified by a chartered accountant.
 - vii No objection certificate from respective Village-Council/Municipal Corporation
 - viii 7/12 extract in the name of business
 - ix PAN card in the name of business
 - x Electricity bill of business area
 - xi Map showing the distance of manufacturing unit/plant of applicant from Bhusawal TPS

Note: Ash will be issue on STA (subject to availability) basis and from designated place/ as directed by competent Authority of BTPS.

B. Terms and Conditions

- Bidder should be ash product manufacturer (i.e. manufacturer of bricks, sheets, blocks, tiles, construction products, wall panels, cement sheets etc.) with SSI/ DIC certificate.
- Bid evaluation and rate applicability shall be strictly as per QR documents and bid document and decision by the auction committee in this regard shall be final and binding on all bidders.
- EMD: Rs. 1/MT of quantity quoted. Limited up to Rs. 10,000 whichever is less.
All bidders found eligible after PQR will deposit EMD to MAHAGENCO. Only approved bidders having sufficient EMD with MAHAGENCO shall be able to participate.
- Security Deposit :- 5 % of the annual order value limited up to Rs. 1 Lakh
- Penalty :-
Penalty for Short Lifting at rate of Rs.10/MT for non-lifted quantity to be calculated quarterly.
- If any agency fails to lift 70% of the allotted quantity consecutively for the period of Three months, the sale order will be terminated.
- Total Balance quantity (un lifted by agency, balance quantity after e-auction, balance quantity after termination) will be made available to the demanding agencies at Highest quoted rate in e-auction on First come first serve basis
- Bidders may quote the annual quantity required against a price starting from floor price and with increment for bidding of Rs. 1.00.
- Contract period: One year from the date of issue of order
- There will be no lower limit for bid evaluation below which the tender will be declared unsuccessful.
- Successful bidders should have to lift the ash from designated places only.
- You have to follow all MPCB norms related to ash transportation.
- You have to follow all safety and security related rule within BTPS plant premises.
- Any damages to MAHAGECO property within BTPS plant premises will be recovered.
- If any illegal activity observed within BTPS plant premises, order will be cancelled with immediate effect.
- All successful bidders should quote to match the rate with H1 bidder of the BTPS respective slabs in the following manner:
