This office has sought Legal Opinion from legal expert, Mr. Anup Mohta, Retd. HC Judge, that with reference to relevant clauses of the Contract, whether MSPGCL is liable to pay taxes and duties on transactions between L&T and its sub-contractors, for supply of Cement & structural Steel.

As per the legal opinion received from the legal expert; MSPGCL is liable to pay L&T the full price shown in the 'Price Schedule' including taxes and duties on transactions between L&T and its sub-contractors. Copy of the legal opinion is enclosed herewith.

The legal opinion received as above, was submitted for appraisal and acceptance of Hon. CMD, MSPGCL, vide office note under ref-3. The subject office note is duly approved by Hon. CMD, MSPGCL.

This is for further needful regarding reconciliation of retained amount of Excise Duty on transactions between M/s L&T and its sub-contractors for supply of Cement & structural Steel, within the limit of estimated amount of Taxes & Duties prevailing as on record date as per the LoA under ref-1.
